iSCSI Cake END-USER LICENSE AGREEMENT FOR YOUNGZSOFT CO.LTD.

IMPORTANT-READ CAREFULLY: This iSCSI Cake End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and YOUNGZSOFT Co. LTD for the iSCSI Cake identified above.

By installing, copying, or otherwise using the iSCSI Cake, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use the iSCSI Cake.

# 1. GRANT OF LICENSE.

Install and use the iSCSI Cake on a single computer and make one copy of the iSCSI Cake in machine-readable form solely for backup purposes. You must reproduce on any such copy all copyright notices and any other proprietary legends on the original copy of the iSCSI Cake. Install the iSCSI Cake on a storage device, such as a network server, and run the iSCSI Cake on an internal network, provided the number of concurrent users does not exceed the number of copies of the iSCSI Cake purchased. A copy of the iSCSI Cake must be purchased for each such user. If you have purchased a multi-pack license for the iSCSI Cake, such as a Ten-Pack license, or a license to make multiple installations of the iSCSI Cake, you may concurrently use the number of copies of the iSCSI Cake authorized by that purchase. Make copies of the End-User iSCSI Cake and distribute those copies for use solely by yourself or personnel employed by you, or by another party, solely for its own internal purposes.

# 2. COPYRIGHT:

The iSCSI Cake is owned by YOUNGZSOFT Co. LTD and is protected by People's Republic of China copyright laws and international treaty provisions. You may not copy the printed materials accompanying the iSCSI Cake (if any), nor print copies of any user documentation provided in on-line or electronic form.

## 3. OTHER RESTRICTION:

You may not make or distribute copies of the iSCSI Cake, or electronically transfer the iSCSI Cake from one computer to another or over a network.
